Purpose of the Policy

To make utilization decisions, Health Alliance uses written criteria based on sound clinical evidence for appropriately applying the criteria.

Statement of the Policy

To apply objective and evidence-based criteria when determining the medical appropriateness of health care services.

NOTE: Please refer to plan documents for prior authorization status/necessity.

Interpretations

- 1. The following are not covered by Health Alliance, because they are not considered basic Health Care Services:
- 1.1 Driver Assessment Programs
 - These programs assess driving performance/capabilities and provide recommendations for measures to increase the patient's cognitive and/ or physical skills to a level needed for safe driving and not covered by Health Alliance.
- 1.2 Isotechnology B200, Work Capacity, Work Hardening, Vocational Rehabilitation
 - These are considered work-related programs and not covered by Health Alliance.

1.3 Marriage Counseling

- Marriage Counseling is individual or couples counseling for marital problems and not covered by Health Alliance.
- 1.4 Voice Clinic
 - This is a team approach for the evaluation and treatment of voice disorders common to the individual whose livelihood depends upon extended use of the voice and not covered by Health Alliance
 - Note: Medically necessary services related to the voice are covered.
- 1.5 Weight Loss, Exercise, and Fitness Programs
 - Charges for special formulas, food, supplements, special diets, minerals, vitamins (e.g., amino acid supplements, Optifast liquid protein meals, NutriSystem pre-packaged foods, Medifast foods, grocery delivery) or Physician and non-Physician supervised weight loss programs are not covered. Organized proprietary programs such as Weight Watchers, Jenny Craig, Diet Center or similar programs and Physical fitness programs, membership in fitness or aquatic facilities, home exercise

equipment, sport activities and equipment are not covered. This does not exclude coverage for medically appropriate rehabilitative services.

- 1.6 Treatment of Specific learning disabilities (including dyslexia, dyscalculia, dysgraphia, and other learning differences) is not a covered benefit at any age. These services are provided in schools under the US Individuals with Disabilities Education Improvement Act. As early as possible children and adolescents should be provided with learning accommodations and instructional modifications to maximize their learning. For adults newly diagnosed or with persistent problems with these conditions, there are no known specific medical treatments which have been proven effective for them. (Ref. 1, 2)
- 1.7 Educational and Training Programs: Health Alliance in general does not cover group educational and training programs, including but not limited to those submitted with the <u>CPT/HCPCS Codes below</u>. Similar to Medicare, Health Alliance does not cover S codes.
- 1.8 Medicare Advantage Criteria details: Medicare also does not cover the above activities.
 - For work hardening reference, see Physical and Occupational Services See LCD/LCA information in grid below.
 - CPT 97545 Work hardening/conditioning; initial 2 hours; and
 - CPT 97545 Work hardening/conditional; each additional hour
 - These services are related solely to specific work skills and will be denied as not medically necessary for the diagnosis or treatment of an illness or injury.
 - They are statutorily non-covered service; the patient is liable for payment according to Medicare.
